- ❖ **Should not exceed 5000 words (exclusive of footnotes)**
- ❖ **Co-Authored paper with a maximum of two authors permitted**
- ❖ **In case of co-authorship, at least one of the authors must attend the Conference to present the paper.**
- ❖ **In case any student intends to present the paper of any faculty member, oral presentation shall be allowed only if the said student is co-author.**
- ❖ **Main text should be in Times New Roman with font size 12 pts. and spacing 1.5.**
- ❖ **The footnotes should be in Times New Roman, font size 10pts. with single spacing.**
- ❖ **One inch margins on all sides of the paper should be maintained. Citation style: Blue Book, 19<sup>th</sup> Edition.**
- ❖ **The paper must be accompanied with scanned copies of the duly filled in Registration form, DD details and cover letter as required for the Abstract stated above.**

**All Papers must be the original and unpublished work of the author.**

**Plagiarized version in any form will be rejected out rightly.**
