In partial modification of SERB sanction order no. SB/YS/LS-351/2013 dated 5 August, 2014, Sanction of SERB is hereby accorded to the additional provision of Rs. 4,66,000/- (Rs.Four Lakh Sixty Six Thousand Only) under 'Manpower(PI Fellowship)' due to the enhancement in the fellowship amount from Rs.35,000/- to Rs. 55,000/- per month w.e.f. 1st October, 2014, thereby increasing the total cost from Rs. 19,00,000/- (Rs.Nineteen Lakh Only) to Rs. 23,66,000/- (Rs.Twenty Three Lakh Sixty Six Thousand Only) for the implementation of above mentioned project.
